## LEGISLATIVE UPDATE:

---

The Federation's Legislative Committee was active during the second regular session of the 126<sup>th</sup> Legislature. We focused our efforts on two bills: LD 1154 *An Act To Establish the Maine Length of Service Award Program* and LD 1622 *An Act To Amend the Laws Governing Firefighter Absence from Work for Emergency Response*.

LD 1154, also known as the LOSAP bill has been the Federation's number one priority for the past decade. As everyone connected to the fire service knows, recruitment and retention of volunteer and call firefighters is a major problem in the fire service in Maine. It is an issue in all parts of the state with large and small departments alike. For several years we have worked to create a statewide program that would be a modest retirement program for volunteer and call firefighters. Although legislators all seem to recognize the recruitment and retention issues, we have never been able to get a LOSAP bill out of committee before. This year though the Legislative Committee decided to focus all of its efforts on the LOSAP effort. With that focus and with the unflinching efforts of Rep. Joyce Maker who sponsored the bill for us and then bird-dogged it through the legislative process, the bill passed finally on April 17 and was sent to the governor for signature. As of the date of publication we do not know what the governor will do with the bill.

As with every bill, we did not get everything we wanted. The original bill would have been funded by doubling the sales tax on fireworks and then using half of the revenue to fund the program. The Labor Commerce Research and Economic Development Committee amended the bill to eliminate the tax increase but to provide that one half of the existing revenue from fireworks sales be used to fund the program. The Appropriations and Financial Affairs Committee amended the bill further to eliminate the state funding altogether. While this is a disappointment in the short term, it may make the bill palatable to the governor. If so, LOSAP will be on the books and we will work to get funding next year in the 127<sup>th</sup> legislature.

Regardless of what the governor does with the bill though, we will not lose sight of the fact that we took this bill farther than we ever have in the past. The votes are there and we know we can do it again. If he vetoes it, we will be right back with a new bill next year.

LD 1622 was a bill designed to clarify an existing law. In 2005 the legislature enacted 26 MRS which makes it illegal for employers to discipline employees for arriving at work late if the reason the employee was late was that he or she was engaged in an emergency response. The law as written only covered true "volunteer" firefighters. As such it really did not cover very many in the fire service. This bill amended the existing law to cover all emergency responders. The legislature passed the bill and the governor signed in on March 16.

As many of you know, the legislative process is often frustrating and difficult. Thanks again to Representative Maker for her efforts on the LOSAP bill. Thanks also to all of you who took time from your lives to come to Augusta for hearings and workshops or to contact your legislators to make them aware of these important issues. It all mattered.

Vogell's 50+ years of dedicated service to the Town of Castine and Hancock County at a departmental awards ceremony. The event is scheduled for Wednesday, May 7th from 5-7 PM in the upstairs auditorium of Emerson Hall, the Castine Town Office located at 67 Court Street.

A lifelong resident of Castine, Assistant Chief Vogell was born in the small Castine Hospital and attended both the Adams and later the Abbott Schools in Castine before graduating from Bucksport High School. Upon graduation, he entered the Navy and served in numerous combat operations during the Vietnam War onboard a Patrol Boat, River (PBR) in the capacities of engineer, engineman, runner and Boat Captain. Upon completion of his combat tour, he returned to the United States and worked as a mechanic in Bangor and later for the Town of Castine before taking a job in the boiler house at the Bucksport paper mill, where he worked until retirement. Today, Vogell continues to fish for shellfish and lobsters in Penobscot Bay as he has done since the age of 14.

Assistant Chief Vogell began his earnest involvement with the Castine Fire Department in 1962 at the age of 16. And, with the exception of his time in Vietnam, he has remained an active member of the Department since that time. He has filled many positions of responsibility within the Department over the years, and was first promoted to the rank of Assistant Fire Chief in 1972. He later served as the Fire Chief from 1973-1979. He then served as Assistant Fire Chief from 1983 to 1995, and again from 1999 to the present time. He spearheaded Castine's transition to the 911 system and incorporation into the Hancock County Regional Communications Center, to include all of the necessary mapping and road/house numbering/labeling. Most recently he managed the successful transition of all the Department's communications systems through the FCC mandated public safety narrow-banding process. Through the years, Vogell has served in many additional roles as a board member, project

**Lamoine** – Lamoine's Volunteer Fire Department is getting ready to put its brand new tanker truck into service. The truck holds 1,800 gallons of water and is equipped with a 1,000 GPM pump, giving it potential flexibility as an attack vehicle. The Town of Lamoine voted to borrow \$194,000 and the fire department agreed to donate \$25,000 raised over several years through auctions, dinners, and a letter writing campaign to help fund the truck. Another \$9,000 came from a fire truck reserve fund. The body was constructed by K&T Environmental Equipment in Island Falls and is mounted on a 2014 International chassis. It was delivered in mid-March and once it's lettered it will be in service. The addition gives the department two tankers, each holding the same amount of water. The other tanker is the fleet's oldest truck at 25-years old which will remain in service for now. The department also runs two class "A" pumpers, a fast attack/brush truck and a small rigid hull rescue boat.



**Bucksport** – Bucksport fire has replaced its Engine 4, which was a 1984 Pierce with a 1000 GPM waterous pump with a new Engine 3, which is a 2013 Rosenbauer pumper-tanker. 1250 GPM with inline foam system and an 1800 gal tank. This is all mounted on an International chassis. This will be our first due vehicle for mutual aid calls. See photo of both trucks together.

We were also very lucky to have received assistance from the Maine Forest Service being awarded a Volunteer Fire Assistance Grant that will help us boost our rural water supply equipment with some much needed adapters and fittings, Thank you Maine Forest Service.

Here in Lovell we have the very popular Lake Kezar of which we provide fire protection for with a marine response however, our 40 year boat would no longer answer the call due to its age and repairs were far too expensive to put money towards a 40 year old boat. So we started a boat campaign to raise money for a new boat to fit our needs, this campaign was a huge success and the citizens of our community far exceed our exceptions and a just a few months we raised enough money to order a new boat. The boat that the department chose is a Rescue One Connector Boat made of aluminum it has a rescue platform at the bow, a center console, a light bar tower with LED lights and is powered by a 40HP Mercury outboard Jet Drive. This boat is a great addition to assist with our water response and will be outfitted with a pump and hose for response to boat, island or shoreline fires. Our thanks to the citizens of Lovell!
